Urban Shield...

The Urban Shield law enforcement training program has been mischaracterized as merely a SWAT-team exercise and weapons expo.

I was present during the meeting in 2007 when then-newly elected Alameda County Sheriff Greg Ahern asked command staff to develop a program that raised the level of emergency training for all public safety officers based on real-life events.

Urban Shield was created to ensure coordination with other police agencies, fire departments, local and state municipalities, hospitals, search and rescue teams and emergency medical responders

This continues to be the cornerstone of what Urban Shield is all about.

In today's environment, it's essential to be prepared for the unexpected. There used to be a time when parents didn't have to worry about their children playing outside until the streetlights went on or walking to and from school. Unfortunately, those are distant memories. Now, first-responders must train and be prepared like never before to protect their communities.

Urban Shield is that one-of-kind training exercise that prepares first-responders for the unthinkable cowardly acts of terrorists, criminal masterminds, active shooters, the mentally ill or any number of natural disasters like fires, floods or earthquakes.

Whatever the event, police, fire and ambulances will be the first to respond, the first to take control and the first to render the scene safe. Training for these catastrophic events has become the new normal.

And, in most cases, local jurisdictions do not have the resources or capacity to meet these demands alone. They must develop partnerships, and skills to coordinate outside resources and understand the proper use, limits and capacity of mutual aid.

Close to home, there are important lessons learned from historic events like the Oakland Hills fire, Loma Prieta earthquake and Napa fires. Events like these will happen again and, most importantly, the first-responders must be well-trained and prepared to handle such situations.

Past practice and training is an indicator of future behavior and success. That's why it's so critical that first-responders receive the best, most-realistic training possible. Urban Shield fits that criteria like no other.

Since its inception, Urban Shield has expanded and now trains thousands of local, state and federal police officers, fire department and emergency medical services personnel, hospital staff, search and rescue teams and community members.

Last year's Urban Shield provided crucial training to over 6000 individuals in active-shooter situations, hostage rescue and mass causality, to name a few. It also trained teams experienced in explosive ordnance, hazardous materials response and maritime/water rescue.

Urban Shield 2017 also hosted a Community Preparedness Fair, where community members were given tools and information they will need to take care of themselves, their families and neighbors until help can arrive after an emergency or disaster. This included learning how to put together a quick, low-cost emergency kit, and basic preparedness for senior citizens, persons with disabilities and the hearing-impaired.

Ideally, tragic events would never occur in our local community or around the nation ever again. But if they do, first-responders must be well-trained, proactive and prepared to meet any challenge, or any threat.

That's why Urban Shield was created, and that's why it has become the premier training for first-responders not only locally, but throughout the nation.

In 1974 when Martin Kauffman was forming our Club he reached out to Frank Ivaldi. Frank was a Hayward businessman known for his work on civic causes and philanthropy that makes the community better (part owner of the Oakland Raiders too). As a result, Frank became one of the first Board members for the M. K. 100 Club. A few years later Frank's brother, Ernest Ivaldi, became a Board member as well. Frank's son, Ron, watched as his dad and uncle work to help families left behind when Police and Firefighter Heroes gave their lives to protect our citizens. Ron Ivaldi became a member in 1981. Soon after he volunteered to serve on our Board and became Club President in 2000. Ron's wife, Linda, is a life member, his sister, Marj, and his son, Jim, are also members. Starting to see a pattern here, are we?

Frank died in 1995. A few years after his dad's passing, Ron founded the Frank Ivaldi Memorial Golf tournament held at the then family owned, Sunol Valley Golf Club. Ron said about the tournament, "For about ten years with the help of a lot of good people the tournament raised a little over one million dollars!". This money was split between two charities – our 100 Club and the CHP 1199 Foundation. Note: Both non-profits help the families that police and firefighter heroes leave behind.

In addition to the golf tournament, the Ivaldi's hosted our annual Winter Dinner at their resort for about 25 years, starting in the late 1980's. The resort closed in December 2015. Today, our committee members planning the Winter dinners still can't believe how low the cost was when our event was held at the Ivaldi's golf course! Long time members know why. The Ivaldi family was keeping the cost low as another way to help our Club!

Not through yet... In 1995, Ron's daughter, Lisa, followed in the family tradition by joining our Club. Lisa contributed to the organization of the annual FOI Memorial Golf Tournament and the Club's annual dinners. After serving on the Board and going through the different officer positions, Lisa Ivaldi Granzella, became our Board president on February 6, 2018. Lisa's presidency occurs about 44 years after Martin Kauffman's phone call to her grandfather!

Are Frank Ivaldi's great grandchildren going to join the M.K. 100 Club? Well, Lisa has five children, four sons (ages 14, 19, 21 and 27) and one daughter (age 10). They will be watching mom for sure, so I wouldn't bet against it!!

Charley Plummer - the Leader!

Most of you know retired Sheriff Charley Plummer died at the age of 87 on March 4, 2018. His beloved wife Norma preceded him in death by about eight months. Charley served 54 years in Alameda County Law Enforcement. He started his career with the Berkeley Police Department in 1952, went on to be chief of the Hayward Police Department in 1976. He was elected and subsequently sworn in as Sheriff in January 1987.

I was a sergeant working in Internal Affairs when Sheriff Charles C. Plummer (CCP) showed up for his first day in office. In those days there were parking meters all around the courthouse by Lake Merritt. Police officers, inspectors and sheriff deputies driving unmarked police cars would routinely park in the meter zones and put the radio microphone cable over the mirror so that the meter reader wouldn't give them a ticket. At that time my partner, Bill Smith, and I watched the new Sheriff park his unmarked



police car in a metered spot and fill the meter with quarters! Watching this, Bill said, "I think things are going to be a little different Jimmy". No truer words would be spoken at that time. What follows are some examples of CCP's way of leading a large police organization.

Longevity: CCP loved police work. Many reports say he was the longest serving cop in California history! Both his sons became peace officers, had great careers and retired before their dad. He told me how some cops would question his decision thinking he had never done their job. They didn't realize that he earned his chops. He started as a "policeman clerk" in 1952. Because he was a good typist he got the policeman clerk job that was paid \$50 more per month. During his 24 years at Berkeley P.D. he was transferred and or promoted to patrol, vice investigator, juvenile detective, sergeant, lieutenant, captain, up to acting chief.

Leadership: CCP believed that great leaders should motivate their employees of all levels to do a better job and be better people overall. I was attending a staff meeting with about 30 ranking members when CCP brought up his opinion that you can tell a lot about an individual by looking at their shoes! Later I noticed that appearances improved at each level! I know I gave my brogans an extra swipe of the brush each morning now that I knew our leader was looking!

CCP motivated people by taking them out of their comfort zone. Shortly after becoming Sheriff, he asked me how much public speaking experience I had. I told him that I had none. A few days later he told his undersheriff that I was going to be master of ceremonies for an upcoming promotional ceremony! I had about one day to prepare and was scared to death! CCP wasn't afraid to make someone a little uncomfortable while he helped them to improve skills. He had a unique sense of seeing people's potential.

Sense of Humor: A few weeks after I started working for CCP he asked me to observe a reporter interviewing him about the gas chamber which was still in use at San Quentin. The reporter, being brand new, was very nervous. When asked what he thought about the gas chamber, CCP thought for a moment then said, "I think they should take the chair out". Then his voice rising fast said, "So the guy can flop around like a chicken!". The reporter was startled. He looked at me and then back at CCP. CCP was starting to smile, then we all had a big laugh. The reporter relaxed and got his official story. He went on to have a great career and fondly remembered his first interview with CCP. CCP even gave him and many other reporters his home phone number in case his perspective was needed on an important story.

CCP believed a short temper was a cop's worst enemy. Humor was very important to him. He felt it was a way to get through the stressful situations encountered by cops of all ranks. For example, there are not many Sheriff's Office

employees who can't recall coming out of a bathroom at one of the many substations and encountering CCP. He would immediately say "Did you wash your hands?". An awkward moment was followed by laughter from both parties. He did this with judges, members of the Board of Supervisors and private citizens as well.

Willing to change: In my time working with CCP I saw him tear up once. At the time of the Loma Prieta earthquake the Board of Supervisors had just made him Sheriff-Coroner. When CCP visited the Cypress Freeway collapse site and saw the loss of life, he saw what a toll it took on his staff as well. They were working long hours, often doing gruesome work recovering the many victims. Soon after this disaster CCP instituted new policies to help all employees who have to work in such conditions get psychological help. Thereafter these procedures became the norm in these types of situations all over the country. Prior to this disaster, CCP, would use the macho excuse that a cop should be able to handle anything and go get a stiff drink or two later that evening. He changed and his employees benefitted.

Guts: It's not easy to point out to someone that he/she is making a mistake. I recall CCP telling deputy sheriffs in uniform to stop standing with their hands in their pockets. Appearance is half the battle. CCP felt if a deputy looks like he/she can't do the job they are at a disadvantage. When I see an officer today with hands in their uniform pockets I think what CCP would say to them!

Fun Trivia: I've been using CCP for Charles Clifford Plummer. Most don't know CCP's middle name was Clifford. He hated it! I found out the hard way while investigating a hate mail case. When I interviewed him, I asked about his middle name, I never brought it up again! Also, He used to laugh as he knew that many of his employees (and former employees) because of his strong command of presence and leadership style referred to him as Complete Control Plummer (CCP).

Final: I could go on for pages about CCP. But suffice it to say he was a good cop, and a good person, who became a great leader because he had the guts to say what he knew from experience to be true! I have one regret about working for CCP. I wish I could have worked with him in the late 1950's in the Vice detail at Berkeley P.D. Can you imagine how much fun that would have been?
