The 100 Club of Alameda History

"The purpose of the Martin C. Kauffman One Hundred Club of Alameda County is to provide for the widows, widowers and dependents of police officers and firefighters from Alameda County, who lose their lives in the line of duty." While visiting Stockholm Sweden, in early 1974, Martin C. Kauffman, an Alameda land developer and prominent citizen of Alameda County, met a fellow American who was a member of the One Hundred Club of Detroit. The gentleman explained to Martin the history of the One Hundred Club of Detroit.

The idea of the club was - and still is - very simple: Members of the One Hundred Club now only pay annual dues of \$150 and \$2000 for lifetime memberships to create and maintain a fund to "help provide for the widows, widowers and dependents of police officers and firefighters who lose their lives in the line of duty from Alameda County." Martin immediately saw the merit in such a program and on returning home. He set about getting a club going in Alameda County.

Martin said, "Starting a One Hundred Club was not easy. Fortunately, I knew a lot of people in Alameda County, many of them through my association as a planning commissioner for 23 years. And I started with them."

He didn't waste any time. While having dinner with friends Walt Raimondi and Don Murphy, Martin told them about his plan to establish a 100 Club in Alameda County. "They immediately responded by becoming the first members. It escalated from that point on, Martin says." They established the first benefit at \$1000.

In February 1974 before the club was officially started, two officers of the Oakland Police Department were shot and killed in an Oakland schoolyard. Using his own money, Martin presented a \$1000 check to each of the widows of the slain officers.

In early June of the same year, two police officers with the East Bay Regional Park District were killed in a helicopter crash. Again, Martin drew on his own resources to give a \$1000 check to the two widows.

Gradually, The 100 Club grew in size. In 1975, it had 60 members; in 1980, 224 members; in 1995, 1000 plus members. To this date, The Club has over 900 active memberships.

In the early days, while Martin was getting new members and promoting the club, Martin's wife Linda, kept the records and did all the necessary paper work. Because of her many extraordinary contributions to the Club, Linda was elected an honorary director, later becoming a full director.

The 100 Club of Alameda History (continued)

The Martin C. Kauffman 100 Club of Alameda County is a 501 (C) (3) not for profit charitable organization providing immediate financial support to Spouses of police officers and firefighters killed in the line of duty in Alameda County. The Club also provides college scholarships and educational benefits for the children of the police officers and firefighters killed in the line of duty in Alameda County. It also provides a Christmas benefit to each spouse and child.

A board of directors and three standing committees; Scholarship, investment policies and nominations govern the Club. The nomination committee is made up of past presidents. The board currently consists of 27 members.

The annual summer barbecue and winter dinner began in the late 1970s, in order to give the Club some continuity through the year and create a feeling of fellowship among the members. Until these two social events started, the only contact a member had with the club was when he got a statement for his dues once a year and there was no contact between club members. The quarterly newsletter, (The informer) started in the early 1990s to keep the members better informed about their club.

The first 100 Club was organized in 1950 after a police officer in Detroit was killed while serving a routine traffic ticket. A number of executives at General Motors raised \$500 for the officer's family, and the 100 Club concept was born. There are currently over 100 active clubs in the US, 7 in California and 5 in the Bay Area.

On August 7, 1991, by a vote of the membership, the Club honored its founder by changing the clubs name to Martin C. Kauffman 100 Club of Alameda County. Earlier, Martin was elected Chairman of the board for life.

Asked what the long-term goal he had for the 100 club, Martin said, "I want the club to continue to do just what it has done since its founding. We have a simple mission and we have a simple way of operating. We will continue to fulfill that mission; to honor and care for the families of police officers and firefighters who lose their lives in the line of duty in Alameda County"
