Alameda County Deputy Dies after Accident

Our Club recently helped the family of Deputy Sheriff Mike Foley, who died in the line of duty on February 23, 2017, after an accident while he was working at the Santa Rita Jail in Dublin. Mike was a 39 year police veteran. He served 30 years with the Concord Police Department and then joined the Alameda County Sheriff's Office. In situations like this, Police and Sheriff's Departments often appoint a member who was a friend and co-worker to serve as a "family liaison". This person assists the officer's family during the funeral and other important and often



emotional events- like when our Clubs President presents a check to the family.

As such, Sheriff Greg Ahern assigned veteran Deputy Keith Bryan to serve as the liaison for Deputy Foley's family. Make no mistake, this is not an easy assignment. While helping the family, the liaison often has to suppress their own feelings and delay grieving themselves while they help others. I asked Deputy Bryan to tell our readers about his friend and co-worker Deputy Mike Foley. What follows are his thoughts:

Dear M. K. 100 Club Members,

Thank you for the opportunity to let you know about Deputy Mike Foley. Mike was a rare breed of a law enforcement officer, one that any supervisor would love to have working for them. For starters Mike showed up every day and never used one day of sick time in the nine years he worked for the Sheriff's Office. He was usually in his uniform and ready to go to work 30 minutes before the start of his shift and was often the last to leave. Mike not only did his work but often helped others, offering his many years of experience to teach the newer deputies.

Mike was not only the hardest worker I have ever known (in my 41 years of police experience) but he worked more overtime than you can imagine. Mike was able to schedule his overtime around important family dates, like his son's football games. Family was very important to him.

But what really set Mike apart was the way he treated people. Co-workers, citizens and yes, prisoners too, were all treated fairly. When dealing with problematic situations in the jail or on the street his firm but easy going demeanor could melt away any resistance. He got the job done with class.

There are only two types of people that knew and worked with Deputy Mike Foley, those who liked him and those who loved him. I guess you can tell which category I'm in.

On behalf of over 1000 Alameda County Deputy Sheriffs' I want to thank your organization for helping the Foley family. I especially want to point out the assistance provided to his son who had just started his college career when his dad was killed. College for his son was a top priority and one of the reasons Mike worked so many hours!
